CAP ezi-parts – Win a Coffee Break Campaign – October to December 2024

Terms and Conditions

- 1. These Terms and Conditions apply to the Capricorn 2024 CAP ezi-parts 'Win a Coffee Break' campaign promoted by Capricorn Society Limited (ACN 008 347 313) of Level 19 / 141 St Georges Terrace, Perth, Western Australia 6000 (the "Promoter") The Promoter can be contacted at the above address or by phone on 0800 401 444 or by email at csl@capricorn.coop.
- 2. The promotion is open to NZ Capricorn Members only and runs from 1 October 2024 to 31 December 2024 ("Promotion Period").
- 3. The prize consists of 3 Coffee Break prizes to be won each month, with a total of 9 to be won during the Promotion Period.
- 4. The promotion is open to NZ Members who make a purchase on their Capricorn Trade Account using CAP ezi-parts during the Promotion Period ("Entrants"). An Entrant receives 1 entry per purchase made on the Capricorn Trade Account using CAP ezi-parts during the Promotion Period.
- 5. There are no restrictions on how many entries an entrant may receive for each monthly prize draw, however entries will be for one prize draw only, being the prize draw occurring in the month following the relevant purchases being made..
- 6. The Promoter in its sole and unfettered discretion will determine in the event of any uncertainty or dispute:
 - a) whether or not a business is a Member eligible to enter the promotion; and b) whether or not an eligible Member is an Entrant, including determining the date on which the purchase using CAP ezi-parts was made.
- 7. The Promoter reserves the right, at any time, to verify the validity of entries and reserves the right, in its sole discretion, to disqualify anyone who the Promoter has reason to believe has breached or does not comply with any of these Terms and Conditions, is not or has ceased to be an eligible Member or Entrant, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the Promotion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 8. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law:
 - a) to disqualify any Entrant;
 - b) subject to any directions required from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.
- These terms and Conditions shall be governed by the laws of the State of Western Australia and of the Commonwealth of Australia and each Member agrees to submit to the exclusive jurisdiction of the courts thereof.



The Prize and Prize Draw

10. The prize draws will take place on the third Monday of the following month at 10:30AM (AWST). All eligible entries received by the Promotor during the relevant month will be entered into corresponding monthly draw as per following table

- 11. The draw will take place at the offices of the Capricorn Society, Level 19 / 141 St Georges Terrace, Perth, Western Australia 6000. The draw will be conducted by computer generated random number generator selection and three winners will be selected at random per month. The Promoter reserves the right to draw and record additional entries for use in the event that the initial entry is invalid or ineligible or the prize is unclaimed.
- 12. The Promotors decision as to the winner is final and no correspondence will be entered into.
- 13. There are a total of 9 prizes to be won. Prizes are a Coffee Break, including food and beverage, provided by the Member's Area Manager. The financial value of the prize is at the discretion of the Area Manager of the winner.
- 14. The Promotor may, in its discretion, substitute a prize or any part of a prize with a prize of equal value (subject to any direction or approval required from any relevant regulatory authority).
- 15. The winners will be informed by telephone or in person, and in writing (which may include by email) within 7 days of the draw. In the event that the winners choose not to accept the prize, they forfeit all and any claims to the prize, and a winner will be redrawn under the clause dealing with an unclaimed prize.
- 16. Details of the winners may also be published in Capricorn Society Limited's trade publication Ignition, e-newsletters and social media channels and other publications.

Unclaimed Prize

17. If a prize is not accepted by a winner or it otherwise goes unclaimed for three months after the draw date, a redraw may take place on two business days after the prize is not accepted or otherwise goes unclaimed with notification of the winner and the timing for claiming and delivery of the prize otherwise occurring in accordance with the timing associated with the initial draw (subject to any direction or approval required from any relevant regulatory authority).

Promotional Activities

18.In the event that they are a winner, the Entrant consents to: a) participating in photo, recording or video sessions as reasonably required by the Promotion; and b) the promoter using their name, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media (including social media) and publications for an unlimited period without remuneration for the purpose of promoting this Promotion (including any outcome), the Promoter and any products arranged, distributed and/or supplied by the Promotor.

Personal Information Collection Statement



19. The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such personal information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to relevant regulatory authorities. Entry is conditional on this personal information being provided. The Promoter will also use and disclose personal information as set out in its Privacy Policy, which can be viewed at www.capricorn.coop. This includes using personal information for promotional, marketing, research and profiling purposes, including sending electronic messages or telephoning the Entrant. We may share personal information across the countries we operate in for the purposes set out or permitted in this statement or our Privacy Policy. We operate in Australia and New Zealand. We and our service providers may also use cloud-based software solutions to perform internal processes which means that information provided to us may be transferred, used or stored outside of Australia or New Zealand.
